### Kennel Name Application Instructions

- The Kennel Name Registration Fee is **\$ 75.00**
- Applicant(s) must be at least 18 years of age to register a JRTCC Kennel Name
- Applicant(s) **must** be current JRTCC Member(s)
- Applicant(s) must have **at least one (1) terrier** (dog or bitch) Registered with the JRTCC
- Applicant(s) submit **two signed copies** of the JRTCC Breeders Code of Ethics with this application

A kennel name is registered with the JRTCC on a lifetime basis, and accordingly will continue to be used as the prefix for any Terrier that you breed that is accepted for Registration or Recording with the JRTCC.

In the case of joint ownership of a kennel name, only one address will be used for purpose of registration records. The **BREEDER** listed on registration and recording documents will be the names of both owners of the kennel name, unless an agreement outlining a different arrangement, signed and dated by both owners, is on file with the Bitch's Registration.

Fill in the Kennel Name Application using Adobe Acrobat, which is a free program. The form has text boxes and dropdown menus. More detailed instructions for how to fill forms is available on the JRTCC website. The application includes an affirmation that the kennel name owner will follow the Guidelines for the Correct Use of Kennel Names, which is included below.

## Jack Russell Terrier Club of Canada Correct Use of Kennel Names (Prefixes)

1. The **PREFIX** in a Terrier's name is always the Kennel Name of the **BREEDER**.
2. The **BREEDER** is defined as the owner of the Bitch (registered or unregistered) at the time of breeding. The owner of a Registered Bitch is considered to be the **BREEDER** of any offspring from said Bitch. If a Registered Bitch has been sold, and the Registration not transferred, the Breeder will be considered the person to whom the Bitch was Registered at the time of breeding. Change of Ownership forms can be found on the JRTCC website and should be submitted to the JRTCC registrar by both the seller and buyer when ownership is transferred.
3. Names of Terriers may include the kennel name as a prefix **only if Kennel Name Registered with the JRTCC, JRTCA, or JRTCGB** (for imported terriers). If the Breeder of a Terrier has a Registered Kennel Name, it **MUST** be included as a **PREFIX** to the Terrier's Registered or Recorded name; if not included on the Registration or Recording applications, it will be added by the JRTCC Registrar.
4. The **PREFIX in a Terrier's name NEVER CHANGES**; it stays with the Terrier for its lifetime.
5. A suffix, even though a Registered Kennel Name, is not included in the permanent Registered or Recorded name of a Terrier. The suffix indicates **CURRENT OWNERSHIP** of a Terrier, and as such, changes with a change of ownership of the Terrier.
6. A Terrier's name, including prefix, is **permanent** once Registered or Recorded.
7. Co-owned Terriers must reflect both owner's names, and a Registered Kennel prefix belonging to **only one of the owners** may be used. A co-ownership agreement outlining the agreed upon Kennel Name, dated and signed by both owners, must be on file with the Bitch's Registration.
